


WHEREAS, the Entity is desirous that the Contractor execute the **IMPROVEMENT OF MP BUILDING AT NEW POBLACION** under Solicitation Number **2021- MPBDLG-20%DF-04-12** and Reference Number **7654364** hereinafter called "the Works" and the Entity has accepted the Bid **NINE HUNDRED NINETY SEVEN THOUSAND PESOS ONLY (Php 997,000.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.




