**WHEREAS**, Republic Act No. 9184 otherwise known as an Act Providing for the Modernization, Standardization and Regulation of the Procurement Activities of the Government and for other purposes mandates the establishment of the Bids and Awards Committee by procuring entities;

**WHEREAS**, the Municipality of Burgos, La Union, thru the Bids and Awards Committee in proper cases, shall recommend to the Head of the Procuring Entity the use of Alternative Methods of Procurement;


