## IMPROVEMENT OF FMR AT SITIO CONIG

THIS AGREEMENT, made this 14<sup>th</sup> day of June, 2021 between the *Municipal Government of Burgos, La Union*, represented by *Mayor Robert B. WHEREAS, the Entity is desirous that the Contractor execute the **IMPROVEMENT OF FMR AT SITIO CONIG** under Solicitation Number **2020-BLU-CA-01-33** and Reference Number **7650852** hereinafter called "the Works" and the Entity has accepted the Bid **THREE HUNDRED NINETY NINE THOUSAND FIVE HUNDRED NINE PESOS AND 49/100 ONLY (PHP 399,509.49)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

3. In consideration of the payment to be made by the party of the first part to the contractor as herein after mentioned, the contractor hereby covenant with party of the first part to execute, complete and maintain the work in conformity in all aspects with the provisions of the contract;
4. The party of the first part hereby covenants to pay the contractor in consideration of the execution, completion and maintenance of the work, the contract price at the times and in the manner prescribed by the contract;


