

IMPROVEMENT OF EVACUATION CENTER BASEMENT

THIS AGREEMENT, made this ^{14th} day of June, 2021 between the *Municipal Government of Burgos, La Union*, represented by *Mayor Robert B. Madarang Jr.* hereinafter called the "Entity" and **GAMIE CONSTRUCTION AND SUPPLY**, represented by **Rowena Natarte Andrada** hereinafter called the "Contractor".

WHEREAS, the Entity is desirous that the Contractor execute the **IMPROVEMENT OF EVACUATION CENTER BASEMENT** under Solicitation Number **2020-BLU-SF-01-30** and Reference Number **7726531** hereinafter called "the Works" and the Entity has accepted the Bid **SIX HUNDRED NINETY NINE THOUSAND TWO HUNDRED EIGHTY SEVEN PESOS AND 30/100 ONLY (PHP 699,287.30)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

 - (h) Eligibility requirements, documents and/or statements;
 - (i) Performance Security;
 - (j) Notice of Award of Contract and the Bidder's conforme thereto;
 - (k) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payment to be made by the party of the first part to the contractor as herein after mentioned, the contractor hereby covenant with party of the first part to execute, complete and maintain the work in conformity in all aspects with the provisions of the contract;
4. The party of the first part hereby covenants to pay the contractor in consideration of the execution, completion and maintenance of the work, the contract price at the times and in the manner prescribed by the contract;
