
THIS AGREEMENT, made this 25th day of May, 2021 between the *Municipal Government of Burgos, La Union*, represented by *Mayor Robert B. Madarang Jr.* hereinafter called the "Entity" and **KING ROWELL II LUMBER AND HARDWARE**, represented by **ROWELL C. TORRES** hereinafter called the "Contractor".

WHEREAS, the Entity is desirous that the Contractor execute the **IMPROVEMENT OF WATER SYSTEMS TOWNWIDE** under Solicitation Number **2021-WSTOWNWIDE-20%DF-04-13** and Reference Number **7654340** hereinafter called "the Works" and the Entity has accepted the Bid **ONE MILLION TWENTY THREE THOUSAND TWO HUNDRED NINETY NINE PESOS ONLY (Php 1,023,299.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

 - (i) Performance Security;
 - (j) Notice of Award of Contract and the Bidder's conforme thereto;
 - (k) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payment to be made by the party of the first part to the contractor as herein after mentioned, the contractor hereby covenant with party of the first part to execute, complete and maintain the work in conformity in all aspects with the provisions of the contract;
4. The party of the first part hereby covenants to pay the contractor in consideration of the execution, completion and maintenance of the work, the contract price at the times and in the manner prescribed by the contract;
