CONTRACT AGREEMENT

THIS AGREEMENT made the 19th day of October, 2021 between the **MUNICIPALITY OF BURGOS, LA UNION** of the Philippines (hereinafter called "the Entity") of the one part and **EYRE PHARMA ENTERPRISES of STA. BARBARA, PANGASINAN** (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **PURCHASE AND DELIVERY OF MEDICAL SUPPLIES IN THE MUNICIPALITY OF BURGOS, LA UNION** with Solicitation Number **2021-BLU-B1-C13** and Reference Number **7988794** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION ONE HUNDRED TWENTY THOUSAND FIVE HUNDRED EIGHTY EIGHT PESOS ONLY (PHP 1,120,588.00)** (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iv. Performance Security;

 - vi. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - vii.
 - viii. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **ONE MILLION ONE HUNDRED TWENTY THOUSAND FIVE HUNDRED EIGHTY EIGHT PESOS ONLY (PHP**




