Description

THIS PROJECT IS THE RESULT OF PUBLIC BIDDING LAST NOVEMBER 22, 2021 WITH AN ABC OF NINE MILLION PESOS ONLY (PHP 9,000,000.00).

NINE (9) BIDDERS BOUGHT THE BIDDING DOCUMENTS HOWEVER ONLY EIGHT (8) BIDDERS SUBMITTED THEIR ELIGIBILITY REQUIREMENTS AND THREE (3) BIDDERS WITH THE LOWEST BID WERE NOT RESPONSIVE THEREBY THE FOURTH BIDDER WITH THE LOWEST BID WAS DECLARED RESPONSIVE NAMEDLY JD MADRID CONSTRUCTION WITH THE CONTRACT AMOUNT OF SIX MILLION EIGHT HUNDRED THIRTY FIVE THOUSAND SIX HUNDRED SIXTY FOUR PESOS AND 90/100 ONLY (PHP 6,835,664.90) WHICH HAS A REMAINING OF TWO MILLION ONE HUNDRED SIXTY FOUR THOUSAND THREE HUNDRED THIRTY FIVE PESOS AND 10/100 ONLY (PHP 2,164,335.10).

ON MARCH 18, 2022, THE BAC CONVENEED AND DECIDED TO USE THE REMAINING AMOUNT FOR THE SAME PROJECT BY USING THE ALTERNATIVE MODE OF PROCUREMENT UNDER RULE XVI, SECTION 53.4 OF THE REVISED IRR OR RA9184 WHICH IS ADJACENT/CONTIGUOUS PROCUREMENT.

ON MARCH 21, 2022, THE BAC CONDUCTED A NEGOTIATED MEETING WITH JD MADRID CONSTRUCTION TO PERFORM ADDITIONAL WORK ITEM SIMILAR TO THE ORIGINAL PROJECT THEREFORE THE SAID PROJECT WAS AWARDED TO JD MADRID CONSTRUCTION ON MAY 24, 2022.
