## CONTRACT AGREEMENT

THIS AGREEMENT made the 21st day of December 2022 between the **Municipal Government of Burgos, La Union** represented by **DELFIN C.   - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **ONE MILLION FIVE HUNDRED THIRTEEN THOUSAND ONE HUNDRED SIXTY FOUR PESOS ONLY (₱1,513,164.00)** or such other sums as may be ascertained, **Eyre Pharma Enterprises**
