CONTRACT AGREEMENT

THIS AGREEMENT made the 27th day of December, 2022 between the **Municipal Government of Burgos, La Union** represented by **DELFIN C. COMEDIS JR.** hereinafter called the "Entity" **FARMERS ZONE TRADING of Acop, Caponga, Tuba, Benguet**, (represented by **IMELDA B. SACPA** hereinafter called the "Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PURCHASE AND DELIVERY OF FLOATING FEEDS, CATFISH AND FISHNET TO BE USED IN THE MUNICIPAL AGRICULTURE OFFICE** under Solicitation Number **2022-BLU-MAO-GF-12** and Reference Number **9147340** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWO HUNDRED SEVENTEEN THOUSAND FOUR HUNDRED FIFTY FIVE PESOS ONLY (P 217,455.00)** (hereinafter called "the Contract Price").

 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
