CONTRACT AGREEMENT

THIS AGREEMENT made the **29th day of May, 2023** between the **Municipal Government of Burgos, La Union** represented by **DELFIN C. COMEDIS JR.** hereinafter called the "Entity" **EYRE PHARMA ENTERPRISES OF SAN FERNANDO, LA UNION**, (represented by **JOSE CARLOS N. PASION** hereinafter called the "Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PURCHASE AND DELIVERY OF MEDICINES AND MEDICAL SUPPLIES** with **Solicitation Number 2023-BLU-RHU-04-18** and **Reference Number 9673227** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWO MILLION NINE HUNDRED SIXTY FIVE THOUSAND EIGHTY SEVEN PESOS ONLY (PHP 2,965,087.00)** (hereinafter called "the Contract Price").

 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;



 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
