## CONTRACT AGREEMENT

THIS AGREEMENT made the 14th day of August, 2023 between the **Municipal Government of Burgos, La Union** represented by **DELFIN C. COMEDIS JR.** hereinafter called the "Entity" **TRT ENTERPRISES** of #194 Tiwala St., Pasolo Valenzuela, (represented by **EDWARD BONE ALCANTARA** hereinafter called the "Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PURCHASE AND DELIVERY OF BACKHOE LOADER** with Solicitation Number **2023-BLU-DRR-28** and Reference Number **9882911** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWO MILLION FIVE HUNDRED NINETY NINE THOUSAND PESOS ONLY (Php 2,599,000.00)** (hereinafter called "the Contract Price").

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **TWO MILLION FIVE HUNDRED NINETY NINE THOUSAND PESOS ONLY (Php 2,599,000.00)** or such other sums
