CONTRACT AGREEMENT

THIS AGREEMENT made the **9th day of June, 2023** between the **Municipal Government of Burgos, La Union** represented by **DELFIN C. COMEDIS JR.** hereinafter called the "Entity" **Burgos Construction Supplies of Bilis, Burgos, La Union** (represented by **MINDA S. LUBID** hereinafter called the "Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **RESTORATION/REHABILITATION OF COMMUNAL IRRIGATION SYSTEM AT DELLES** with Solicitation Number **2022-BLU-CA-02** and Reference Number **9810133** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE HUNDRED SEVENTY EIGHT THOUSAND THREE HUNDRED FIFTY PESOS ONLY (PHP 178,350.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **ONE HUNDRED SEVENTY EIGHT THOUSAND THREE HUNDRED FIFTY PESOS ONLY (PHP 178,350.00)**.or such other sums as may be ascertained, **BURGOS CONSTRUCTION**



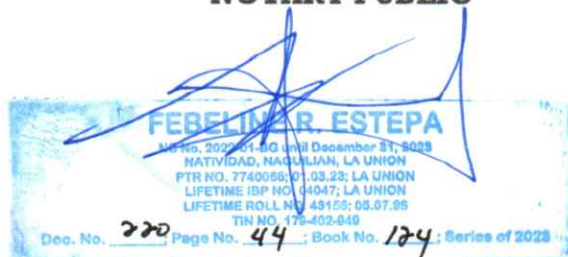
