CONTRACT AGREEMENT

THIS AGREEMENT, made this 6th day of **November, 2023** between the **MUNICIPAL GOVERNMENT OF BURGOS, LAUNION** (hereinafter called the "Entity") and **FELVIC ENTERPRISES of no. 0111 Bayacsan, Taloy Sur, Tubao, Benguet** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **CONSTRUCTION OF FLOOD CONTROL AT SITIO LOWER DELLES (GASCON AREA)** with Solicitation Number **2023-BLU-DRR-30** and Reference Number **10092238** (hereinafter called "the Works") and the Entity has accepted the Bid for to **TWO HUNDRED NINETY NINE THOUSAND ONE HUNDRED SIXTY NINE PESOS AND 58/100 ONLY (PHP 299,169.58)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
 - d. Notice of Award of Contract and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **TWO HUNDRED NINETY NINE THOUSAND ONE HUNDRED SIXTY NINE PESOS AND 58/100 ONLY (PHP 299,169.58)** or such other sums as may be ascertained, **FELVIC ENTERPRISES** agrees to *execute, complete and maintain the work* in accordance with his/her/its Bid.


