CONTRACT AGREEMENT

THIS AGREEMENT, made this 6th day of **December, 2023** between the **MUNICIPAL GOVERNMENT OF BURGOS, LA UNION** (hereinafter called the "Entity") and **BHM CONSTRUCTION/VICEROY CONSTRUCTION J.V., with office address at PA399-D, Upper Wangal, La Trinidad, Benguet** (hereinafter called the "Contractor").

 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs.
