## CONTRACT AGREEMENT

THIS AGREEMENT made the 12<sup>th</sup> day of **SEPTEMBER, 2024** between the **MUNICIPAL GOVERNMENT OF BURGOS, LA UNION** of the Philippines (hereinafter called "the Entity") of the one part and **NORTHERN ASIA SALES CORPORATION** of **NATIONAL HIGHWAY, NANCAYASAN URDANETA CITY, PANGASINAN, PHILIPPINES** (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PURCHASE OF EQUIPMENT/TOOLS/MACHINERIES FOR TOBACCO PRODUCTION** with Solicitation Number **2024-BLU-21RA7171-10** and Reference Number **11186145** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **NINE HUNDRED FIFTY FOUR THOUSAND TWO HUNDRED TWELVE PESOS ONLY(954,212.00)** (hereinafter called "the Contract Price").

  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
  - iii. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iv. Performance Security;
  - v. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - vi. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **NINE HUNDRED FIFTY FOUR THOUSAND TWO HUNDRED TWELVE PESOS ONLY(954,212.00)** or such other sums as may be ascertained, **NORTHERN ASIA SALES CORPORATION** agrees to **DELIVER EQUIPMENT/TOOLS/MACHINERIES FOR TOBACCO PRODUCTION** in accordance with his/her/its Bid.
