BAC Resolution Declaring LCRQ and Recommending Approval RESOLUTION NO. 2025-9000-02-17C

WHEREAS, Republic Act No. 9184 otherwise known as an Act Providing for the Modernization, Standardization and Regulation of the Procurement Activities of the Government and for other purposes mandates the establishment of the Bids and Awards Committee by procuring entities;

WHEREAS, the Bids and Awards Committee in proper cases, shall recommend to the Head of the Procuring Entity the use of Alternative Methods of Procurement;

WHEREAS, RA9184 requires the posting of every bidding opportunity except in case provided by the same law;

WHEREAS, after following the procedures of RA9184 on public bidding, the BAC has already declared the failure of bidding for the **INSTALLATION OF SOLAR STREETLIGHT** with Solicitation Number **2025-8000-12-12** and Reference Number **11769901** for Barangay Dalacdac of Burgos, La Union twice on **January 25, 2025** and **February 10, 2025**;

WHEREAS, in order to promote economy and efficiency, the Bids and Awards Committee recommends **Negotiated Procurement – Two Failed Biddings** for the **INSTALLATION OF SOLAR STREETLIGHT** for the Municipality of Burgos, La Union;

WHEREAS, the municipality invited three contractors for negotiation but only one contractor submitted an offer as follows:

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the prospective contractor with the Lowest Calculated Responsive Quotation, **MYLENE'S DRY GOODS STORE**, it has been found to be responsive.

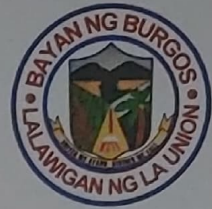
NOW THEREFORE, We the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:
