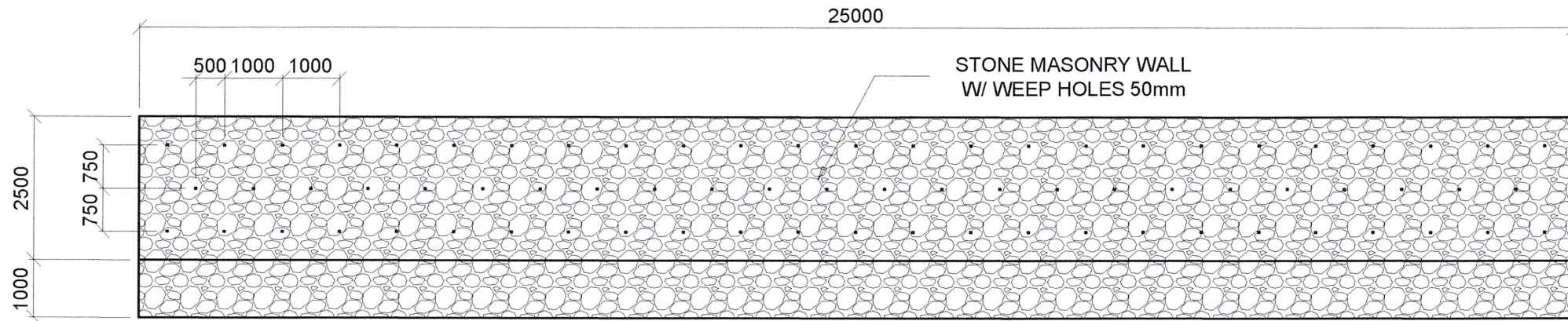
Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from Municipality of Burgos, La Union and inspect the Bidding Documents at the address given below from Monday to Thursday only at 8:00 am to 5:00 pm.
5. A complete set of Bidding Documents may be acquired by interested bidders on **JUNE 26, 2025 to JULY 10, 2025 before 10:00 AM** from given address and website below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **PHP 500.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

6. The Municipality of Burgos, La Union will hold a Pre-Bid Conference<sup>1</sup> on **JUNE 26, 2025** at Municipal Conference Hall, Municipality of Burgos, La Union, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **JULY 10, 2025 on or before 10:00am**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **JULY 10, 2025** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. Bidders' Representative should have **Special Power of Attorney (SPA)** duly signed by the owner of the Construction Firm/Company indicating the specific details of representation.
11. Interested bidders can submit and request for eligibility checking from the BAC – TWG (For the schedule, refer to the BAC-TWG Head/Member)
12. The Procuring Entity of the Municipality of Burgos, La Union does not conduct online procurement. 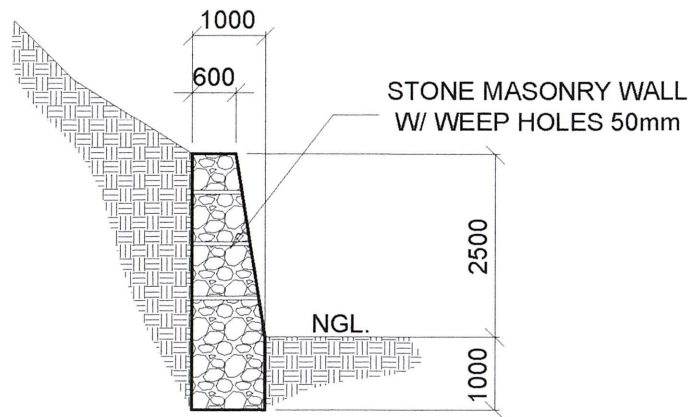
