SECTION 2. REPEALING CLAUSE: All ordinances, resolutions and Executive Orders found to be inconsistent to the provisions of this Ordinance are hereby repealed or modified accordingly.


SECTION 3: EFFECTIVITY: This Ordinance shall take effect in accordance with law.
