RESOLUTION NO. 009-2026

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON DELFIN C. COMEDIS, JR. TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) THROUGH DSWD-FO1, REPRESENTED BY REGIONAL DIRECTOR MARIE ANGELA S. GOPALAN FOR THE IMPLEMENTATION OF THE SOCIAL PENSION FOR INDIGENT SENIOR CITIZENS (SPISC) IN THE MUNICIPALITY OF BURGOS, LA UNION

WHEREAS, under Section 2 (h) (1) of Republic Act No. 11916 of the "Act Increasing the Social pension of Indigent Senior Citizens and Appropriating Funds Therefor, amending for the purpose Republic Act No. 7432", indigent senior citizens shall be entitled to monthly stipend amounting to not less than One Thousand Pesos (P1,000.00) to augment the daily subsistence and other medical needs of senior citizens;

WHEREAS, **DSWD**, as the lead agency in social welfare and development, has implemented the Social pension for Indigent Senior Citizens (SPISC) since 2011 through DSWD Field Offices (FOs) in all regions;

WHEREAS, Section VII (D) of DSWD Memorandum circular 006-2024 of the Enhanced Omnibus Guideline in the Program Implementation of the Social Pension for Indigent Senior Citizens, allows fund transfer to LGUs as one of the payout modalities in the implementation of delivery and distribution of the stipend to the SPISC beneficiaries;

WHEREAS, the DSWD FO1 identified fund transfer to LGUs as an efficient and effective mechanism in implementing the social pension for indigent senior citizen program in their respective territorial jurisdiction;

WHEREAS, for the past years, the Municipal Government of Burgos, La Union has a good track record in implementing efficient mechanisms in delivering the cash payout to the social pension beneficiaries down to the barangay level;






