AN ORDINANCE ESTABLISHING THE BARANGAY COMMUNITY GARDEN THAT WILL SERVE AS A STRATEGY TO DIVERSIFY THE FOOD SOURCE AND CONTINUE TO ENSURE FOOD SECURITY IN THE COMMUNITY IN BARANGAY DELLES, BURGOS, LA UNION IDENTIFY ITS LOCATION AND ENSURE ITS IMPLEMENTATION AS PROVIDED FOR IN THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT MEMORANDUM CIRCULAR NUMBER 2023-001 DATED JANUARY 3, 2026 DULY SIGNED BY SILG ATTY. BENJAMIN C. ABALOS, JR.

On motion of **EFREN C. PADILLO**, unanimously seconded by all the members present, be it **ORDAINED**, by the Sangguniang Barangay of Delles, Burgos, La Union in session assembled that:

Section 1: The Ordinance shall be known as Barangay Community Garden of Barangay Delles, Burgos, La Union.

Section 2: AREA AND LOCATION OF THE BARANGAY COMMUNITY GARDEN.

2.1 The community garden shall be located at Sitio Cabugao, Delles, Burgos, La Union, with a land area of 100 sqm. or its equivalent in several patches of land.

Section 3: IDENTIFIED PLANTS THE BARANGAY WISH TO GROW.

3.1 The barangay shall plant; string beans; pechay; okra; tomatoe; eggplant; squash; etc.

Section 4: ALTERNATIVE GARDENING THE BARANGAY IDENTIFIED TO ADOPT:

4.1 The barangay will implement alternative gardening such as container gardening, vertical. Gardening such as container gardening, vertical gardening, square foot gardening, hydroponics, aquaponics and aeroponics.

4.2 The barangay may coordinate and request from the municipal government for any vacant property owned by the local government or the private individual who own A certain vacant lot that can be used to establish the barangay community garden.

4.3 The barangay shall encourage their residents to set up their family vegetable garden. And/or plant fruit-bearing trees in available open spaces.

Section 5: Roles and Responsibilities of the Barangay

5.1 Ensure the re/organization and strengthening of the Barangay Nutrition Committee. And include in the Barangay Development Plans (BDP) and Annual Investment Programs applicable nutritional programs, projects, and activities to ensure adequate Funding of nutritional impact.

5.2 Designate one (1) SBM to lead and manage the establishment and maintenance of the BCG through an eo,; Designate form among the barangay officials and staff including the Barangay Nutrition Scholar who shall assist in the operations and maintenance of the BCG.

5.3 Identify the areas where the BCG shall be established and set-up BCG in vacant areas. Preferably owned by the barangay or local government. Designate a SBM to coordinate with the Municipal Agriculture Officers or its equivalent for training and Capacity-building on agriculture in the barangay.

5.4 Keep a record of the overall operations of the BCG and submit necessary reports to the DILG-M/LGOO.

Section 6: EFFECTIVITY. This ordinance shall take effect in accordance with law.




