MUNAR, MDM, FPAFB, FOR THE CONDUCT OF DRUG TESTING OF MUNICIPAL EMPLOYEES IN THE LOCAL GOVERNMENT UNIT OF BURGOS, LA UNION

WHEREAS, the Local Government Unit of Burgos, La Union is committed to maintaining a drug-free workplace in furtherance of Municipal Ordinance No. 85-2020 otherwise known as **"AN ORDINANCE INSTITUTIONALIZING A DRUG-FREE WORKPLACE IN THE LOCAL GOVERNMENT OF BURGOS, LA UNION & APPROPRIATING FUNDS FOR THE IMPLEMENTATION THEREOF;**

WHEREAS, **DOH-SAN FERNANDO LA UNION TREATMENT AND REHABILITATION CENTER (TRC-La Union)** is accredited by the Department of Health and Philippine National Police to conduct urine drug testing for dangerous drugs, possessing the necessary facilities, qualified personnel, and quality control measures;

WHEREAS, the parties agree to collaborate for the conduct of mandatory, random, and confirmatory drug testing of municipal employees to ensure public, safety employee wellness and compliance with legal mandates;




