RESOLUTION NO. 017-2026

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON DELFIN C. COMEDIS, JR. TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH WITH THE DEPARTMENT OF HEALTH ILOCOS CENTER FOR HEALTH DEVELOPMENT (DOH Ilocos CHD) REPRESENTED BY DIRECTOR IV PAULA PAZ M. SYDIONGO, MD, MPH, MBA, CESO III AND DR. CARLO AR-AR C. ARIZABAL, FOR THE IMPLEMENTATION OF THE DOCTORS TO THE BARRIOS (DTTB) PROGRAM IN THE MUNICIPALITY OF BURGOS, LA UNION

WHEREAS, the LGU, by virtue of Republic Act No. 7160 Section 77, is responsible for the provision of health services and facilities in their areas of jurisdiction. The LGU, considered as one of the priority areas in the Philippines by the DOH, is in dire need of a physician who will assist the LGU in improving its local health system performance;

WHEREAS, Section 24.2 of Republic Act No. 11223 or Universal Health Care act seeks to augment health workforce needs of local public health systems, the DOH shall secure positions to hire professionals and health workers for deployment under the National Health Workforce Support System.

WHEREAS, the DOH implements the Human Resource for Health (HRH) Deployment Program to promote access to quality health services to marginalized, vulnerable and disadvantaged population of the country, to improve health outcomes and to contribute to the attainment of health-related Sustainable Development Goals (SDGs);

WHEREAS, one of the composite programs of HRH Deployment Program is the Doctors-to-the-Barrios (DTTB) Program, which aims to deploy physicians in priority areas, especially hard-to-reach, far-flung, doctorless municipalities, to assist in the improvement of local public health systems;




