RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE DELFIN C. COMEDIS, JR., TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE OWNERS OF A LOT, MODESTO QUILACIO, MAURICE ENERO QUILACIO AND FREDERICK PAJARILLO QUILACIO FOR THE OPENING AND CEMENTING/PAVING OF THE DONATED PARCEL OF LAND LOCATED AT UPPER TUMAPOC, BURGOS, LA UNION

WHEREAS, MODESTO QUILACIO, MAURICE ENERO QUILACIO and FREDERICK PAJARILLO QUILACIO, are the registered owners of a land located at Upper Tumapoc, Burgos, La Union covered by Transfer Certificate of Title No. T-29212, TCT No. 025-2023000854 with a total area of eighty thousand square meters (80,000 sq. m.);

WHEREAS, for the common good and welfare of the community, the DONORS hereby freely, voluntarily and irrevocably DONATED a portion of the aforesaid property with an area of seven hundred thirty square meters (7,730 sq.m.) more or less, to the Local Government Unit of Burgos, La Union;

WHEREAS, the registered owners of the lot and Mayor Delfin C. Comedis, Jr. wish to set out their respective obligations for the opening and cementing/paving of a road at the donated portion which shall be used as a public road serving Upper Tumapoc and neighboring barangays;
