RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE DELFIN C. COMEDIS, JR., TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF LA UNION FOR THE TRANSFER AND LIQUIDATION OF THE MUNICIPALITY'S PRIZE AS THE 3RD PRIZE WINNER TO THE PROVINCIAL SEARCH FOR THE CLEANEST, SAFEST AND GREENEST (CSG) MUNICIPALITY FOR CY 2024

WHEREAS, Section 16, Article II of the 1987 Constitution provides that "The State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of the nature";

WHEREAS, to ensure environmental protection, the Provincial Government of La Union institutionalized the Search for the Cleanest, Safest and Greenest (CSG) Local Government Units through provincial Ordinance No. 267-2020 and Provincial Ordinance No. 471-2024 entitled: Amending Sections 4,5,8,10 and 11 of the Provincial Ordinance NO. 267-2020;

WHEREAS, the Search for the Cleanest, Safest and Greenest (CSG) aims to mobilize all sectors of the society in transforming and helping their communities into clean, sage, green areas; promoting a venue for people's participation in community development efforts and to institutionalize a system of providing recognition to the local government units throughout the province;

WHEREAS, site validation of the Municipality of Burgos was conducted on September 18, 2025 and was adjudged as the “3rd Prize Winner of the Provincial Search for the Cleanest, Safest and Greenest (CSG) Municipality (4th to 5th Class Category) for CY 2024” garnering 80.99% with a Cash Prize of Five Hundred Thousand Pesos (P500,000.00);

WHEREAS, the parties agree that the cash prize will be used for the Installation of a Renewable Solar Power System at the Municipal Solid Waste Management Facility;

WHEREFORE, on motion of SBM Domingo G. Abansi, duly seconded by all Sangguniang Bayan Members be it;

RESOLVED, AS IT IS HEREBY RESOLVED, to **AUTHORIZE** the Municipal Mayor, Hon. Delfin C. 


