GUZMAN RELATIVE TO THE IMPLEMENTATION OF TULONG SA PANGHANAPBUHAY SA ATING DISADVANTAGED WORKERS (TUPAD) PROGRAM IN THE MUNICIPALITY OF BURGOS, LA UNION

WHEREAS, it is the National Government's policy to implement poverty alleviation project in all regions;

WHEREAS, the Department of Labor and Employment (DOLE) is mandated to promote gainful employment opportunities, develop human resources, protect workers and promote their welfare and maintain industrial peace;

WHEREAS, the DOLE provides assistance to help disadvantaged workers in coping with the closure or slowing down of operations of companies as a result of economic disruptions and/or the occurrence of natural disasters, calamities, or armed conflicts that affect their economic base and to augment the meagre income of the disadvantaged workers under its **TULONG PANGHANAPBUHAY SA ATING DISADVANTAGED WORKERS (TUPAD) PROGRAM**, pursuant to the provisions of D.O. 239, series of 2023;

WHEREAS, the **DOLE-RO 1** has been given the responsibility to implement the TUPAD Program to provide temporary wage employment to the disadvantaged workers for a period of 20 days;
